





Ready, Set, Go... Transitional Planning Conferences

What Is Ready, Set, Go (RSG) / Transitional Planning Conferences (TPC)?

- Support offered to youth to understand and plan for transition and long-term well-being with the emphasis on preparing them for success throughout their teens and up to 23 years of age
- Driven by policy directive, CW 003-23 Preparing Youth for Successful Transition from the Care of Children's Aid Societies (Province of Ontario, April 1, 2023, section 42 of the *Child Youth Family Services Act* (CYFSA).
- The importance of the youth's input on the direction, access and level of support is one of the key drivers of the program
- Six core dimensions are built upon: health, education, identity, family and social relationships, emotional and behavioural
 development and self-care skills. Each of these are considered from the youth's perspective with appropriate guidance in the
 context of age, culture, maturity and experience in order to support their eventual transition out of care and long term
 success

Who is Eligible?

- Youth 13–23 in interim society care for a period of 12 consecutive months with anticipated extended society care
- 16 or 17 years old and in a Voluntary Youth Services Agreement (VYSA)
- In a customary care agreement supervised by a society, and in consultation with each of the youth's bands and FNIM communities
- Youth between 18-23, must meet additional criteria according to section 124 of CYFSA and associated regulations

Services Offered: (all ADR TPC services are free of charge)

- Youth must be offered the RSG program at set intervals (see structure)
- Youth participation in RSG/TPC is completely voluntary at all times

Structure: (ADR-Link is available to work with the youth and CAS worker at each of these stages and any time between)

- At the youth's **13th birthday**, the society is required to examine the Action and Assessment Record (AAR), and the Plan of Care process, with a transition lens applied
- Following the youth's **15**th **birthday**, and no later than three months before their 16th birthday, the society must offer the youth an opportunity to participate in a conference or other forum to support formal transition planning.
- Prior to the youth's 18th birthday, and 23rd birthday the society must document the completion of the checklist provided. (see MCCSS)

Our ADR practitioners are excited to contribute to the success of youth in care along with CAS workers

Refer youth to ADR-Link:

- Youth must be offered access to a conference preferably ADR at prior to 15, 17 and prior to 23 years of age (they may engage at 13 if they wish to have help with the AAR and Plan of Care Process)
- Youth will benefit by working with an ADR practitioner specifically trained to assist them as they question, explore and plan for their futures during and after their involvement with CAS
- ADR will ideally match youth with practitioners who will remain their consistent support at any stage of engagement with RSG
